The competitor will assume full responsibility for application of decals and patches to collect awards. Phoenix will report to sponsor companies based on your application of decals and patches as to award eligibility. All decals and patches must be in place when truck is brought to the inspection line for qualifying. **ARCA Truck Series, Phoenix Management Group of Ohio, Lincoln Welders and Hoosier Tire patches** must be permanently attached on the front side, chest high or above on the driver's practice and race uniforms to be eligible for race purse payout. All drivers' uniforms will be checked for required patches at same time as race truck inspection. Patches must be complete and permanently attached at this time.

# ELIGIBILITY REQUIREMENTS

Field limited to **24 starters plus provisional's (EIRI)** and they must hold a valid 2015 license in ARCA.

This program will be run under the 2016 ARCA Truck Series rules, regulations and specifications. In signing an entry or taking part in any of the events described in this entry blank, all competitors agree to abide by all official PMG decisions and regulations.

Any driver who fails to file an entry before midnight, **July 18, 2016** will receive prize money, but will not be credited with ARCA Truck Series championship pre-entry points for the program. Entries **MUST** be made by mail or fax. **SUNOCO IS THE OFFICIAL FUEL OF PMG. SUNOCO 110 FUEL WILL BE THE ONLY FUEL USED.** Fuel will be available at the track, from a PMG approved supplier.

**All teams are required to purchase 10 gallons of fuel per truck, per event from the PMG supplier.** All trucks must be safety inspected before practice, and be inspected at the designated tech area before qualifying will be permitted. Inspection headquarters at the Speedway will open at **1:00 p.m. on Saturday July 23, 2016** and no trucks will be checked in for inspection after **6:00p.m. on Saturday July 23, 2016 (EIRI)**. All trucks will be subject to PMG control from time they pass inspection until they are officially released after race. All trucks should be able to maintain a minimum safe, unhazardous speed during competition - **ALL DRIVERS MUST PRACTICE BEFORE THEY CAN QUALIFY.**

**ELIGIBLE TRUCKS:** According to Rule Book.

**QUALIFYING:** Fastest lap in session;

**TESTING:** No private race truck practice or test runs shall be permitted for four (4) days immediately preceding the first day of official practice for this event.
